

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF OAK PARK HEIGHTS, WASHINGTON COUNTY, MINNESOTA, TO INCLUDE CERTAIN PLATTED LAND.

THE CITY COUNCIL OF THE CITY OF OAK PARK HEIGHTS, WASHINGTON COUNTY, MINNESOTA, DOES ORDAIN:

1501.01

Purpose.

A. A petition has been filed with the governing body of the City of Oak Park Heights, Minnesota, by a majority of the owners in number of the following described real estate to have such land included within the City of Oak Park Heights, Minnesota:

1. Said land is described as follows and is all located in Township Twenty-nine (29) North, Range Twenty (20) West, Washington County, Minnesota.
2. The Northwest Quarter of the Northwest Quarter (NW 1/4 of NW 1/4) of Section Four (4).
3. The Northeast Quarter of the Northwest Quarter (NE 1/4 of NW 1/4) of Section Four (4).
4. The West Four Hundred Eighty-five and Five-tenths (485.5) feet of the North Eight Hundred Ninety-seven and Two-tenths (897.2) feet of the Southwest Quarter of the Northwest Quarter (SW 1/4 of NW 1/4) of Section Four (4).
5. The Northwest Quarter of the Northeast Quarter (NW 1/4 of NE 1/4) of Section Four (4).
6. The North Forty (40) rods of Northeast Quarter of the Northeast Quarter (NE 1/4 of NE 1/4) of Section Four (4).
7. All of the plat known as "Brekke's Garden Hills" except Lots A, B, C, D, and E.
8. The East Two Hundred Nineteen (219) feet of the North Four Hundred Twenty (420) feet of Southwest Quarter of the Northeast Quarter (SW 1/4 of NE 1/4) of Section Four (4).

1501.02      Size.  
The quantity of land embraced within the foregoing description and bounded as described is \_\_\_\_\_ acres.

1501.03      Council Determination.  
The City Council hereby determines and ordains:

- A.      That the annexation will be to the best interest of the City of Oak Park Heights, Minnesota, and of the territory affected;
- B.      That the territory described herein abuts upon the City and is so conditioned as property to be subjected to City government.

1501.04      Extension.  
The City Council does ordain that the corporate limits of the City are hereby extended to include the property described in Section 1501.01, and the same is hereby annexed to and included in the City of Oak Park Heights as effectually as if it had originally been a part thereof.

1501.05      Filing Copies.  
The City Clerk is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Commission, the County Auditor, and the Secretary of State.
