

AN ORDINANCE ADOPTING A REVISION AND CODIFICATION OF ORDINANCES TO BE KNOWN AS THE CITY CODE OF OAK PARK HEIGHTS: PROVIDING FOR THE REPEAL OF CERTAIN ORDINANCES: PROVIDING FOR THE PUBLICATION OF THE CITY CODE OF OAK PARK HEIGHTS: AND PROVIDING A PENALTY FOR THE VIOLATION OF THE CITY CODE OF OAK PARK HEIGHTS.

THE CITY COUNCIL OF THE CITY OF OAK PARK HEIGHTS, WASHINGTON COUNTY, MINNESOTA, DOES ORDAIN:

- 101.01 Adoption of Code.
This Ordinance consisting of Chapters 101 through 1700, inclusive, is a codification and revision of the ordinances of the City of Oak Park Heights and shall be and is hereby adopted as a single original and comprehensive ordinance to be known as the City Code of Oak Park Heights.

- 101.02 Repeal of Ordinances.
All ordinances of the City of Oak Park Heights heretofore in full force and effect are hereby repealed.

- 101.03 Preservation of Rights.
The repeal of any ordinance or portion thereof by the preceding section shall not affect or impair any act done or right vested or accrued or proceeding, suit or prosecution had or commenced shall remain in full force and effect to all intents and purposes as of such ordinance or part thereof so repealed had remained in force. No offense committed and no liability, penalty or forfeiture civilly or criminally incurred prior to the time when such ordinances or part thereof shall be repealed or altered by the City of Oak Park Heights shall be discharged or affected by such repeal or alteration; that the prosecution and suits for such offenses, liabilities, penalties, or forfeitures shall be instituted and proceeded with in all respects as if such prior ordinance or part thereof had not been repealed or altered.

- 101.04 Amendments and Additions.
Ordinances passed subsequent to this Ordinance shall, where appropriate, be deemed additions or amendments to the City Code. Such ordinances shall be incorporated into the Code from time to time by the printing of revision sheets for inclusion in the Code.

- 101.05 Violation and Penalty.
Any person violating any provision of the City Code of Oak Park Heights shall be guilty of a misdemeanor and upon conviction thereof shall be punished by a fine of not to exceed Seven Hundred Dollars (\$700.00) or by imprisonment not to exceed ninety (90) days, or both.

- 101.06 Publication of Code and Effective Date.

This Ordinance, the City Code of Oak Park Heights, together with such indexes, supplements, appendages or other material as the Council may designate shall be published in loose-leaf or pamphlet form and a substantial quantity of ordinances shall be printed and available at the office of the City Clerk for general distribution to the public. The City Code shall become operative and effective upon its passage and as soon as the City Clerk shall publish a notice for two successive weeks in the official newspaper of the City of Oak Park Heights stating that printed copies of the City Code are available at the office of the City Clerk for general distribution.
